6. THAT the person named in the SCHEDULE 'A' (4) hereto shall be the SECHETARY who shall be in charge of and responsible for the safe custody of all records of the Trust. 9. The Trustees shall hold meetings as often as may be necessary for the conduct and management of the Trust so declared hereinabove. A meeting may at any time be summoned, by the Manag-ing Trustee or any Two Trustee on three days notice to the Trustees of the time, date and place of the meeting as well as the matters to the discussion thereat. A meeting shall be held at such place as the Managing Trustee may decide. Maximum Two Trustees shall form quorum of the meeting.

iv. With a view to carrying out the objects of the Trust hereinbefore mentioned, to augment its fund and administer them and in the discharge of their duties, the Trustees shall have the following power: :-

- (a) To receive any money or further assets in any shape or form as and when given by the founder of the Trust or any other person or persons.
- (b) To receive/accept contributions / donation made with specific direction that they shall form part of the Corpus of the Trust. All such contributions/donations shall be credited to the Corpus Fund A/C.

11. THAT the Trustees may delegate any of their powers to a committee or committees or sub-Committee(s) consisting of such person or persons whether member(s) of their body or not as they may think fit and appoint such committee or any sub-committee as they may from time to time think fit for any of the purposes of the said frust and may frame rules relating thereto and may from time to time add to as well as to vary the same as they shall think fit and proper.

12. THE powers as enumerated in paragraph '10' herein above shall be exercised by the Trustees subject to their satisfying the conditions laid down in sections 11,12 and 13 of the Income-Tax Act,1961 as amended from time to time so that the Income of the Trust may very well be exempt from Income- Tax for each and every assessment year.

13. ALL the Trustees as named hereinabove shall be Trusteesfor- life. In case of any vacancy occasioned by death, resignation or incapacity or otherwise of any such Life-Trustee, the remaining Trustees shall appoint another person(s) as Trustee(s) to fill up such vacancies.

14. Any Two Trustees may, in writing, requisition the Secretary to convene a meeting of the Board of Trustees clearly disclosing the matters to be discussed by the Trustees and thereupon the Secretary shall convene the meeting of the Board of Trustees after giving proper notice of such meeting of the Trustees. In case, the Secretary fails to respond to the requisition of those Trustees, the said Trustees themselves may convene a meeting of the Trustees and the decisions arrived at such meeting shall be as good, valid and binding as if they are the decisions arrived at the meeting of the Board of Trustees duly convened provided that at least two thirds of the total number of Trustees attend such beetings and the decisions are supported by a majority of votes.

Trustees as per this Deed of Trust shall be capable of being performed or exercised by majority of Trustees present at the meeting of the Board of Trustees and any action or decision of such majority shall be subject to the provisions contained in pare 11 supra as valid and effective as it would have been if done by all the Trustees. If, however, in the opinion of the Setetary, the calling of the Trustees is impracticable for any reasons resolution passed by the unanimous consent of the Trustees by circulation of prizers shall be as valid and effective as it passed by the majority of the Trustees at a duly convened meeting.

The Office of the Trustees will be Honorary Trustees shall not be entitled to draw any remuneration ever for carrying out their duties but shall be entitled reisbursed for their actual travelling-expenses and all other incidental charges incurred by them for attending the meetings of the Board.

47.On a New Trustee being appointed and thereby on his signing the Minute-Book to the effect of his having taken charge. the property shall immediately vest in him and he will be enti-tled to carry out all the duties and functions of a Trustee and it shall not be medessary to make or execute any Formal Transfer of assets in his favour. The property shall be deemed automatically to have been transferred in favour of the Incoming Trustees the intention being that the property and the assets of the Trust shall vest and remain vested in the Trustees for the time being of the Trust without the necessity of a formal transfer in favour of any New Trustee who may be appointed in the process.

18.No Business shall be transacted in any meetings of the Trustees unless at least Two Trustees are present. If a meeting is adjourned for want of a quorum, it shall be held on the same day at the same time and the same place in the following week. No business shall be transacted at any adjourned meeting so held next time unless Two Trustees are present. At such adjourned meeting, only the business mentioned in the original agenda of the original meeting (which was adjourned) shall be dealt with.

19.All questions including also the question of appointment of New Trustee at any meeting of the Trustees shall be decided by a majority of votes of the Trustees so present in the meeting provided also that the chairman/ president is having (in addition to the original vote) a casting vote in all cases of equality of votes.

20. The Trustees may dispose off any question or pass any resolution by a circular by majority of them PROVIDED that the same question may be reconsidered at the instance of any one Trustee within three wonths of the passing of such circular resolution.

21. The Trustees shall keep or cause to be kept a book called Minute Book along with all other relevant Records wherein all Libe proceedings of the meetings of the Trustees and resolutions passed thereat or arrived at by circular shall be recasted. Minutes of every such meeting shall be signed and confirmed at the same meeting or at the next following meeting and shall be open for inspection of the Trustees.



23. THE Trustees shall be respectively chargeable only for such moneys or securities as they shall respectively actually receive notwithstanding their respectively signing any receipt for the sake of conformity and shall be answerable and accountable only for their own acts, receipts, neglects, or defaults not those of each other nor for any banker, broker, auctioneer or others persons with whom or into whose hands any Trust -moneys or securities may be deposited or come or for insufficiency in tible or deficiency in value of any investments not for any other loss unless. the same shall happen through their own such willful wrongs respectively.
